1 This Court has reviewed Plaintiffs' Motion for Reimbursement of Settlement
2 Administration Expenses and Disbursement of Net Settlement Funds, which is
3 unopposed and supported by a Declaration of the Settlement Administrator; and a Reply
4 in support of the Motion, which is supported by an updated Declaration of the
5 Settlement Administrator. Plaintiffs ask the Court to authorize (1) reimbursement of
6 settlement administration costs in the amount of \$77,420.60, and a reserve of \$200,000
7 for reimbursement of any such remaining costs that the Court may approve through the
8 completion of settlement administration; (2) disbursement of the net settlement sum to
9 participating class members in the amount of \$10,777,940.16; and (3) disbursement of
10 \$516.49 to class members from the reserve in order to facilitate payment of net
11 settlement proceeds. Upon consideration and for good cause shown, the Court hereby
12 GRANTS the requested relief.

13 IT IS HEREBY ORDERED that:

- 14 1. Reimbursement to Class Counsel for \$77,420.60 charged by the Settlement
15 Administrator for its services is reasonable and adequately documented and
16 thus GRANTED.
- 17 2. A reserve of \$200,000 for reimbursement of any such remaining settlement
18 administration costs that the Court may approve through the completion of
19 the settlement is GRANTED.
- 20 3. Disbursement of the Settlement Class Net Settlement Sum in the amount of
21 \$10,777,940.16 to Participating Settlement Class Members (Settlement
22 Agreement § XI) is GRANTED.
- 23 4. Disbursement of \$516.49 to Participating Settlement Class Members from
24 the reserve in order to facilitate payment of the Settlement Class Net
25 Settlement Sum is GRANTED.
